Confidentiality, Limits of Confidentiality, & Records

All of our communication becomes part of a clinical record, which is accessible to you upon request. I will keep confidential anything you say as part of our counseling relationship, with the following exceptions:

- (a) You direct me in writing to disclose information to someone else,
- (b) It is determined you are a danger to yourself or others (including child or elder abuse), or
- (c) I am ordered by a court to disclose information.

I am a mandated reporter of abuse in the State of Georgia.
